Following are some bills POMA is tracking and recently saw action and are being shared in the November 3, 2023 issue of *Under the Dome*.

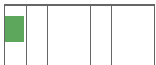

 [HB 1754](#) [Mullins, Kyle\(D\) \(Lackawanna\)](#) Amends The Insurance Company Law of 1921, in casualty insurance, providing for coverage for biomarker testing.

 [HB 1767](#) [Hanbidge, Liz\(D\) \(Montgomery\)](#) Amends the Human Services Code, providing for reporting allegations of abuse; in departmental powers and duties as to supervision, in departmental powers and duties as to licensing, further providing for definitions, for fees, etc.

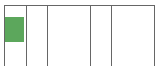
Last Action: 10-31-23 H Introduced and referred to committee on House Education
