1. Use single spacing on the template (see next page).

Not PDF – only Word document.

2. Abstract TITLE:

a. Indicate RESEARCH or CASE REPORT

- b. must be in 10-point **UPPER CASE BOLD** in Times New Roman.
- 3. First author is indicated by an <u>underline</u>. All other co-authors are not underlined.
- 4. All authors are represented by first name, initial, surname, and highest professional degree.
- 5. Each author's respective affiliation is to be indicated with a superscript number which corresponds to the list of affiliations, e.g., Michael Brown, DO¹, Jessica Smith, DO¹, George Doe, MD², etc.
 - List affiliations as follows:
 - 1. Department of Internal Medicine, Blank School of Medicine, City, State.
 - 2. Division of Cardiology, Blank Medical Center, City, State
- 6. Subtitle Format: **INTRODUCTION**; **METHODS**; **RESULTS**; **CONCLUSION** -- in **BOLD**. *All text must be in as appropriate upper and lower 10-point Times New Roman but <u>not bold</u>.*
- 7. Do <u>not</u> include references.
- 8. <u>Only text is to be presented</u> -- no pictures, tables, or graphs.
